

FROM YOUR EDUCATION OFFICER

Ahoy Everyone,

I am thrilled that the ice has finally left Sturgeon Bay and that the water is higher than last year. The lack of snow has not been as decisive a factor as the cold, freezing over 87% of Lake Michigan-Huron this past winter. I see thirty inches of water off a spot on my dock that was dry two years ago. Even though the water is high don't be like me and navigate yourself onto a Dunlap Reef due to a neglecting of your navigation skills. I will try not to have a repeat performance this summer.

I am excited about our education department. We have just completed Cruise Planning. Five students took the course. We held the class at Chuck Holtz's house which was a great setting for the course since Chuck had lots of equipment used for cruising ready at hand. Every student passed the test with flying colors. Students were Terry and Julie Keating, Karl May, Stephen Mayhue and Janelle Peotter. The Cruise Planners will meet aboard Karl May's boat later this spring to plan our summer cruises for the squadron. This will be a nice extension to the classroom part of the course.

Navigation is well underway with Alan Wentworth at the helm. Terry Keating tells me that the students are progressing well and are learning a lot. Terry is doing what I thought was impossible. He is taking both N and JN at the same time. I am in awe of his progress. Five students are taking the class, four of whom are members or associates of our squadron. Alan is using the Go-To-Meeting format to teach the course which is a first for us.

JN is underway with John Welch at the helm and with Bob DeNoto as a co-teacher for some of the chapters and for sight-taking assistance. There are four students in this class and all are proceeding nicely. I think I can safely say that the Prince will stay in our squadron this coming year. I am really excited at the interest in JN and N. I have noticed that these ranks are not common in most squadrons. We will have more than our "fair share" in the coming year. I am taking JN myself and find it very rewarding as I work through it.

Chuck Stone was scheduled to begin Electronic Navigation on 16 April. We need to move the start date to 21 May through 18 June.

Due to Chuck's and his wife's cataract surgeries, they will not be able to come to Door County until the middle of May. This will be a quick four week course with an extra week built in for the exam. Electronic Navigation (the Canadian version) will be accepted as Marine Electronics module three until National comes out with our own version. It is a requirement on the Advanced Coastal Navigator Passport. We will do the ACN this summer, led by Bob DeNoto.

I am planning on six seminars this summer: Anchoring, Basic Coastal Navigation, Boat Handling Under Power, Partner in Command, Trailering Your Boat, and Sail Trim are the ones I am considering. If anyone has any feedback or requests let me know. I will set up dates and topics this month.

ABC is scheduled for June. Please tell any kids you know that they will need a certificate to operate a power boat. This course includes jet skis. Because children must be accompanied by an adult for this course this is a great opportunity to take a safe boating class with your family. I can't think of anything more fun and gratifying than to get a child fired up about boating.
